# THOUSANDS SEE HEALER LAY HANDS ON FAITHFUL

In a tense atmosphere a young man holds in one hand a steel leg brace which had supported his lame limb for over a year.

"My leg is healed," he gasps. "I can walk normally again."

"Glory Halleluja," exclaims a large congregation in amazement. "A-men . . . A-men . . . A-men."

The scene is a big tent at the corner of Ouadra and Pembroke Streets where for two weeks hundreds of sick and ailing people have passed through in the hope of finding some relief for their afflictions . . . hopeless cases of medical science.

More than 2,000 persons are seated in the massive tent where Evangelist A. C. Valdez, Jr., of Arizona, is conducting a faith healing service. The congregation is composed mostly of Victorians, but some have come from distant parts of British Columbia and the United States to see the "miracles."

The young evangelist, a thick set, darkhaired man, wearing a light-grey suit, a white shirt and bow tie, stands on a raised platform. There is nothing striking about his outward appearance. His speech, however, is dynamic, forceful and sometimes deeply emotional.

#### WAIT FOR MIRACLE

Waiting in an aisle is a long line of suffering humanity, young and old, some with faces distorted with pain. Nearby are stretcher cases, cripples in wheel chairs, old people who need some support to stand. They are all waiting . . . waiting for a miracle to happen.

The moment has arrived. All is tense. The faith healer walks to a wheel chair where a thin, pale young man sits. He is paralyzed from the waist down.

"Affliction I curse thee," says the evangelist. "Stand up now, you are getting better."

The man stands. Spectators gasp. Tears roll down the face of a well-dressed grey-haired business man kneeling in prayer.

The preacher moves to another patient. This time to a young Chinese girl on a stretcher. He touches her. The girl cries out: "Thank you God, thank you God." Her small voice penetrates to the far corners of the tent.
